THIS LICENSE AGREEMENT IS BETWEEN GOONONTHETRACK.COM AND [ %CLIENT\_NAME% ] (HEREINAFTER REFERRED TO AS "LICENSEE"), WHO HAS PURCHASED THE UNLIMITED LICENSE FOR THE GOONONTHETRACK.COM BEAT "[ %BEAT\_NAME% ]" - PRODUCED BY GOONONTHETRACK.COM. GOONONTHETRACK.COM AND LICENSEE AGREE TO THE FOLLOWING TERMS AND CONDITIONS:

1. LICENSEE SHALL HAVE THE WORLDWIDE, UNLIMITED NON EXCLUSIVE RIGHT TO SELL UNLIMITED UNITS, BROADCAST ON THE RADIO, AND LICENSEE SHALL HAVE THE RIGHT TO MAKE AN UNLIMITED AMOUNT OF MONEYS FROM THEIR USE OF THE GOONONTHETRACK.COM MUSIC. LICENSEE MAY ALSO USE THE SONG THEY CREATE WITH GOONONTHETRACK.COM MUSIC IN ANY NON-PROFIT PROJECT. THE GOONONTHETRACK.COM MUSIC MUST BE COMBINED WITH OTHER AUDIO (VOCALS) AND NOT BE JUST THE INSTRUMENTAL.
2. LICENSEE SHALL HAVE THE WORLDWIDE, UNLIMITED NON EXCLUSIVE RIGHT TO SYNCHRONIZE THE GOONONTHETRACK.COM MUSIC WITH VISUAL MEDIA (TELEVISION SHOWS, FILM, ADVERTISEMENTS, VIDEO GAMES, MOVIE TRAILERS, ETC.) IN UP TO 10 DIFFERENT FOR PROFIT PROJECTS, LICENSEE MAY ALSO SYNCHRONIZE THE GOONONTHETRACK.COM MUSIC WITH AN UNLIMITED NUMBER OF YOUTUBE VIDEOS.
3. LICENSEE AGREES TO PAY GOONONTHETRACK.COM THE ONE TIME PURCHASING FEE.
4. IN ALL PROJECTS IN WHICH THE GOONONTHETRACK.COM BEAT "[ %BEAT\_NAME% ]" IS RELEASED TO PUBLIC LICENSEE MUST GIVE CREDIT IN ACCORDANCE TO THE FOLLOWING FORMATS:

"PROD BY [GOONONTHETRACK]"

"BEAT BY [GOONONTHETRACK]"

UPON COMPLETION OF FINAL MIX OF SONG RECORDED WITH GOONONTHETRACK.COM BEAT "[ %BEAT\_NAME% ]" LICENSEE IS REQUIRED TO CONTACT GOONONTHETRACK.COM WITH DETAILS FOR REGISTRATION WITH PERFORMANCE RIGHTS ORGANIZATION AND GOONONTHETRACK.COM WILL BE CREDITED AS COMPOSER 100% DURING PERFORMANCE RIGHTS ORGANIZATION REGISTRATION, LICENSEE MUST ALSO RETURN FINAL MIX OF SONG RECORDED WITH GOONONTHETRACK.COM BEAT "[ %BEAT\_NAME% ]" IN .MP3 FORMAT PRIOR TO PUBLIC RELEASE. IF LICENSEE NEGLECTS TO RETURN FINAL MIX OF SONG TO GOONONTHETRACK.COM PRIOR TO PUBLIC RELEASE WHICH LICENSEE HAS PURCHASED AND RECEIVED WITHOUT PRODUCER TAGS THEN THIS AGREEMENT IS VOID AND LICENSEE NO LONGER WILL HAVE THE UNLIMITED NON-EXCLUSIVE USE OF "[ %BEAT\_NAME% ]" RETURN COMPLETED SONG RECORDED WITH "[ %BEAT\_NAME% ]" FULLY MIXED AND MASTERED TO: INFO@GOONONTHETRACK.COM

LICENSEE AGREES TO INDEMNIFY AND HOLD LICENSOR HARMLESS FROM AND AGAINST ANY AND ALL CLAIMS, LOSSES, DAMAGES, COSTS, AND EXPENSES, INCLUDING, WITHOUT LIMITATION, REASONABLE ATTORNEYS' FEES, ARISING OUT OF OR RESULTING FROM A CLAIMED BREACH OF ANY OF LICENSEE'S REPRESENTATIONS, WARRANTIES OR AGREEMENTS HEREUNDER.
